JOB DESCRIPTION AND MAIN TASKS

Assisted by the nursing team, he/she is alone responsible for the following tasks:

- Medical monitoring of pupils in collaboration with the nursing staff: medical visits including, depending on the year of study: medical history, clinical examination (dental, ENT, cardiopulmonary, orthopaedic, skin, genital, etc.) and neuro-paediatric examination;
School visits for pupils must be carried out by the school doctor in person and are organised according to the following timetable on school days (official EEB1 calendar):
 - Uccle site: Monday, Tuesday and Thursday mornings (around 1,600 pupils per school year)
 - Berkendael site: Tuesday and Friday mornings (around 600 pupils per school year)
- Drafting of medical reports for parents;
- Management of prophylaxis and monitoring of communicable diseases;
- Drafting of various reports and letters to various bodies;
- Contacts with parents, GPs, specialists and other health authorities;
- Attendance at meetings where a student's health issues are discussed, where necessary;
- Raising awareness of health promotion among pupils and teaching staff;
- Vigilance against abuse ;
- Advising management on updating medical procedures and purchasing and fitting out medical and paramedical equipment.

PROFILE REQUIRED

- Holder of a doctorate in medicine and a certificate in school medicine (or undertake to complete it at their own expense within 3 years of taking up their post);
- Perfect command of French and very good knowledge of English, both written and spoken;
- Fluency in another EU language is an advantage;
- Flexible organisation and respect for deadlines;
- Resistance to stress and dynamism;
- Excellent communication skills in a demanding multilingual context;
- Autonomy and ability to work as part of a team;
- Proactivity and initiative;
- Excellent respect for confidentiality;
- Ability to manage and process large quantities of information;
- Recent clean criminal record (model 596-2).

OFFER

- Entry into service: 3 September 2025;
- Offer: service contract as an independent doctor; agreement to be drawn up for each school year, possibly renewable after evaluation by the Management; provisional schedule of services to be defined at the beginning of the school year with the nursing teams;
- Remuneration: monthly invoice to be sent to the School for services provided, fee and indexation to be discussed during interview.
- Terms: the school doctor undertakes to carry out the aforementioned medical examinations in person and to attend school meetings as an expert doctor at the request of the Management;
- Timetable: The school year has 180 days, 181 days in leap years. There are no services during the EEB1 school holidays;
- No on-call service required except for health emergencies;
- Place of work: Uccle or Berkendael sites;
- Computerised equipment: Mediris software;
- Support from an experienced team of nurses and psychologists.
